## RECOMMENDED ACTION:

Adopt a resolution to reapportion the territory of the school district into board districts as mandated by 70 O.S. § 5-107A.

## BACKGROUND:

Every 10 years, after federal census results are submitted to the U.S. President, state law requires that board zone boundaries for school districts the size of ours be redrawn to reflect new population data and shifting populations. Normally this would have occurred in 2020. The 2020 census was delayed because of COVID-19, however, so the President did not receive the 2020 census data until 2021. Consequently, Oklahoma schools had to wait to redistrict until 2022.

Board President Dr. Max Venard, Vice President Glen Cosper, Superintendent Brian Ruttman, Assistant Superintendent Terri Helvey, and I worked with the Center for Spatial Analysis at the University of Oklahoma to develop the proposed new district board zone map, shown on the following pages, based on the 2020 census.

The proposed zone map complies with all state requirements for school board zones, summarized as follows:

All boundaries of board districts shall follow clearly visible, definable, and observable physical boundaries - based on criteria established and recognized by the U.S. Census Bureau, such as streets, railroad tracks and, when possible, precinct boundaries. State law further requires board districts "shall be compact, contiguous, and as equal in population as practical with not more than a ten percent (10\%) variance between the most populous and least populous board districts."

After board adoption of the redistricting plan, it will be submitted to ODCTE for approval by the state board at their September meeting.

WHEREAS school districts that are currently divided into board districts for purposes of election are mandated by 70 O.S. § 5-107A to reapportion the territory of the school district into board districts in the year following the submission by the United States Department of Commerce to the President of the United States of the official Federal Decennial Census; and

WHEREAS, board districts shall be compact, contiguous, and shall be as equal in population as practical with not more than a ten percent (10\%) variance between the most populous and least populous board districts; and

WHEREAS, the board of education has carefully reviewed and considered maps of the school district's population in an effort to adhere to the statutory requirements; now, therefore, be it

RESOLVED that the Board of Education, Moore Norman Technology Center School District No. 17, Cleveland County, Oklahoma, has adopted the attached map of board districts for school board elections which shall be utilized until such time as the district is required to be reapportioned.
